

In many instances, these foot soldiers are micro-enterprises and so a side benefit of our tracing services is the creation of jobs through enterprise development. This is a win-win solution: tracing members *and* creating jobs.
- Our aim is to help develop these **micro enterprises** by providing not only a means of income, but also the support required to sustain their business. This includes giving them access to a system which they use to track their cases. Fairheads carries due diligence responsibilities with these partners.
- Many people are naturally suspicious or disbelieving when traced and told that monies are due to them. Our tracing team is highly skilled in **reassuring** the tracee, if necessary, obtaining a letter from the deceased retirement fund member's employer.
